4. Discussions and resolutions on the proposals submitted by National Federations and BOD

a) **Rafts for 2011 - from BOD on behalf of Sport & Competition Committee:**

Choice 1 was unanimous – organisers to continue to provide same rafts

b) **Youth and Veteran Categories - from Czech Boaters Union BoD:**

Agreed that new sub-com for Youth & Veterans would put together proposal of rules for Youth to present to S&C Com.

c) **Euro Champs R4 and / or R6 - from Czech Boaters Union BoD:**

Agreed to move it to Euro Committee to discuss

d) **H2H penalty - from Czech Boaters Union BoD:**

Jury from WRC 2009 is drawing up a proposal to solve this issue and will present it shortly to S&C Com for discussion.

e) **Rule: tie in points - from Czech Boaters Union BoD:**

This rule change plus any others people want are to be presented to Ondrej who will collate them and send them out to all S&C Com for discussion. Once the discussions are finalised all the new rule changes will be done at one time.

f) **Reconsider Point System - from Japan Rafters Federation:**

Declined - Time Trial will continue to have points. (A discussion was held about the fact that some teams will not get to paddle H2H due to the present format being used.)

g) **Slalom Rules - from Swiss Rafting Federation:**

- i. Proposed to change rules to say upstream and downstream poles must be different colours – this will be included in Rule Discussions coming up.
- ii. Pole size – declined, stay as is.
- iii. Sanctions – declined, stay as is

5. **Any other business if time allows:**

Yuni proposed that it be in the rules that a camera must be available for Judges to view footage. Discussion ensued as to whether only official cameras or anyone's cameras. This to be included in Rules Discussion coming up.
